## **REQUIREMENTS FOR FILING TRADEMARKS IN GRENADA**

Trademarks in Grenada are governed and filed in accordance with the Trademarks Act No. 1 of 2012. The Act is regulated by Statutory Rule & Order No. 18 of 2012.

According to the Act, a trademark is “any sign capable of being represented graphically, which is capable of distinguishing goods or services of one undertaking from those of other undertakings” (Section 2 (1), Trademark Act No.1 of 2012).

Hereunder is a list of requirements for the respective services:

### **Registration**

- 1) Authorisation of Agent – this form must be duly completed and executed by the owner or a representative of the company by which it is owned. Where the owner of the mark is a company, the seal of the company is required to be affixed on the form. There is no requirement for the notarization or legalization of this form.
- 2) Your official instructions in writing (e-mail or hard copy) – These instructions should contain a replica of the trademark and the details of the respective class(es) in which the trademark is to be registered.

### **Renewal**

- 1) Authorisation of Agent.
- 2) Your official instructions in writing (e-mail or hard copy) – These instructions should contain a replica of the trademark and the details of the prior registration in Grenada, namely the Registration Number.

### Change of Proprietor's Name and or Address

- 1) Authorisation of Agent.
- 2) The original or a certified copy of the document evidencing the respective change. All documents are required to be replicated in English.
- 3) Your official instructions in writing (e-mail or hard copy).

### Assignments/Change in Ownership

- 1) Authorisation of Agent.
- 2) The original or a certified copy of the document evidencing the assignment (namely a deed of assignment) or the document evidencing the change in owner.
- 3) Your official instructions in writing (e-mail or hard copy).

### Searches

- 1) Your official instructions in writing (e-mail or hard copy).

### Trademark Oppositions

- ❖ Kindly contact us **immediately** should any conflict related to your trademark registration arise.

**\*Depending on the nature of your request, the Registrar may request additional documentation or require specific legalization of respective documents.**

**\*All applications will be prepared and filed by our office. The Authorisation of Agent form is to be completed by you and the original or hard copy forwarded to our office.**

**\*A certificate will be provided by the Registrar of Trademarks for every successful application filed.**
